ACA L1 Tandem Canoe Instructor Certification Workshop (L1 ICW)

Description of the ICW

There are numerous benefits to becoming certified as an ACA (American Canoe Association) Instructor:

- Significant improvement in your own canoeing skills
- Learning how to teach others to canoe
- Instructor discounts from major manufacturers
- Insurance for courses that you teach
- The satisfaction of being recognized as a proficient canoeist

The first day of the ICW focuses on strokes, the second day introduces additional strokes and rescues, and the third day focuses on refinement of strokes, and rescues. Risk assessment/safety management, group management, and teaching, are integrated throughout the three days. Although this ICW is designed for Tandem canoe certification, you will also learn and refine Solo canoe skills. A significant amount of time is devoted to improvement of personal skills, so you should leave the ICW as a significantly improved paddler. Given the attention paid to personal improvement, this course is also an excellent choice for canoeists who want to improve their skills and are not interested in instructor certification.

In order to ensure a solid training experience, ACA requires a minimum of four participants in order to run this ICW. Class size is limited to twelve.

You should be aware that participating in the workshop does *not* guarantee that you will be certified. There are specific ACA criteria and tasks that you need to satisfy. However, if you are willing to do some preparation, and if you are open to coaching in order to refine the necessary skills, you stand a very good chance of becoming certified.



Instructor Trainer Background

Steve Henkind is the highest ranked ACA kayak instructor/trainer on the entire Gulf Coast, from Florida to Texas. His ACA certifications include L2 Touring Canoe Instructor Trainer, L3 Coastal Kayak Instructor Trainer, L4 Open Water Coastal Kayak Instructor, L3 River Kayak Instructor, and ACA Adaptive Paddling Instructor. In addition to his ACA credentials, Steve has also been a member of the U.S. Coast Guard in various capacities for over 20 years. Given his Coast Guard and medical backgrounds, he takes safety very seriously. His classes are fun and highly educational, but safety is always the first priority.
